# NOTICE OF EXTRA-ORDINARY GENERAL MEETING

### SPECIAL BUSINESS:

Resolution 1: To consider and if thought fit, to pass the following, with or without modification, as special resolution of the Company:

"That on the recommendation of the Directors and in accordance with the Memorandum and Articles of Association and the requirements of the Companies and Allied Matters Act, 2020, the authorized share capital of the Company be and is hereby reduced from N15,000,000,000 (Fifteen Billion Naira) divided into 30,000,000,000 (Thirty Billion) shares of 50k each to N7,000,000,000 Seven Billion Naira) divided into 14,000,000,000 (Fourteen Billion) Ordinary Shares of 50k each, by cancelling 16,000,000,000 (Sixteen Billion) unissued ordinary shares of 50k each from the total existing share capital of the Company.

Resolution 2: To consider and if thought fit, to pass the following, with or without modification, as special resolution of the Company:

"That the Directors be and hereby authorized to do all acts and things to give effect to resolution 1 by ensuring compliance with necessary statutory requirements and obtain relevant regulatory approvals and appropriate court sanctions".

# PROXY
