

NOTICE OF ANNUAL GENERAL MEETING

NOTICE IS HEREBY GIVEN that the 12th Annual General Meeting of GEREGU POWER PLC will hold on the Thursday, March 28, 2024 at 10:00 a.m. at The Jewel Aeida, 105, Hakeem Dickson Link, Lekki Phase 1, Lagos, Nigeria to transact the following business:

ORDINARY BUSINESS

- To present the Report of the Directors, Statement of Financial Position with the Statement of Profit or Loss and other Comprehensive Income for the year ended 31st of December, 2023 and the integrated reports of the Auditors and Audit Committee thereon.
- 2. To declare a dividend.
- 3. To ratify the appointment of Chief. Olukunle Oyewole Esq who was appointed as an Independent Non- Executive Director since the last Annual General Meeting.
- 4. To re-elect the following directors retiring by rotation:
- a. Mr. Anil Dua
- b. Mr. Doron Grupper
- 5. To authorize the Directors to fix the remuneration of the Auditors.
- 6. To elect/re-elect the members of the Audit Committee.
- 7. To disclose to the shareholders the remuneration of managers of the Company.

- 9. That the Memorandum and Articles of Association of the Company be amended to read as follow:

Directors:



- a. **Article 21** 'Fully paid shares shall be free from any restriction on the right of transfer and shall also be free from all lien, except as otherwise prescribed by the operation of law'
- b. Article 47 _"All regulatory announcements by the Company shall be published in at least two (2) daily newspapers with nationwide circulation"
- c. Article **48** 'Where it is provided that notices shall be given only to those members whose registered addresses are within Nigeria, any member whose registered address is not within Nigeria, may name an address within Nigeria which for the purposes of notice, shall be considered as the registered address.'
- d. Article **72** ''Unless and otherwise directed by a resolution of the general Meeting of the company, the number of directors of the Company shall not be less than 6 or more than 13''
- e. Article **91** 'The borrowing powers of directors are limited so that the aggregate amount at any time owing in respect of moneys borrowed by the company and its subsidiary companies (exclusive of intercompany borrowings) shall not exceed a reasonable amount except with the consent of the company in general meeting;'

<u>Proxy</u>

A member entitled to attend and vote at the Annual General Meeting is entitled to appoint a proxy to attend and vote in his stead. A proxy need not be a member of the Company. For the appointment to be valid, a completed and duly stamped proxy form by the Commissioner of Stamp Duties must be deposited at the office of the Registrar, Meristem Registrars and Probate Services Limited, 213, Herbert Macaulay Way, Adekunle, Yaba, Lagos not less than 48 hours before the time fixed for the

meeting.

Closure of Register of Members

Notice is hereby given that the Register of Members and Transfer Books of the Company will remain close from 28th February, 2024 to March 4, 2024 to enable the Registrar prepare for payment of dividend.

Election/ Re-election of Directors

In accordance with the provisions of the Companies and Allied Matters Act No. 3 of 2020 (as amended), a resolution will be proposed for the election of Chief Olukunle



Oyewole who was appointed since the last AGM. Furthermore, the Directors to retire by rotation at the Annual General Meeting are Mr. Anil Dua and Mr. Doron Grupper. The retiring Directors, being eligible, offer themselves for re-election.

Statutory Audit Committee

The Audit Committee shall, in accordance with Section 404 of the Companies and Allied Matters Act No. 3 of 2020 (as amended) ("CAMA") consist of 5 (five) members comprising of 3 (three) members and 2 (two) non-executive directors. Furthermore, the members of the audit committee are not entitled to remuneration and are subject to election annually. Any member may nominate a shareholder as a member of the audit committee by giving written notice of such nomination to the Secretary of the Company at least 21 (twenty-one) days before the Annual General Meeting.

Kindly note that by virtue of the provisions of the Code of Corporate Governance issued by the Securities and Exchange Commission and the CAMA, all members of the Statutory Audit Committee should be financially literate and at least one member must be a member of a professional accounting body in Nigeria established by an Act of the National Assembly and be knowledgeable in internal control processes.

Dividend Payment

If approved by the members at the Annual General Meeting, dividend will be paid on Thursday, 28th March, 2024 or Thursday 4th April, 2024 at the rate of N8 per every ordinary share (subject to appropriate deduction of withholding tax) to shareholders whose names appear in the Company's Register of Members at the close of business on Tuesday, February 27, 2024.
