... Earnings Normalises as FX-Linked Windfall Disappears

Earnings Note

Events

Following the bottom-line weakness recorded in Q1 2025, Q2 did not provide much relief as profit after tax declined 26% year on year to N116.16bn from N156.47bn in Q2 2024. The pressure came largely from a 45% contraction in non-interest income, as the N143.38bn gains recognised on financial instruments at fair value through profit or loss (FVTPL) in Q2 2024 reversed into a N5.75bn loss in Q2 2025. Despite this, gross earnings rose 33% year on year to N913.72bn from N686.67bn as interest income remained strong, accounting for 89% of gross earnings compared with 73% in Q2 2024.

Strong Interest Income Momentum

Interest income grew by 62% to N812.13bn, supported by a 74% growth in income from loans and advances to customers which printed at N546.15bn, alongside N223.47bn from investment securities and N42.51bn from loans to banks. The uplift was driven by a 7% year to date expansion in interest earning assets (IEA) and a relatively elevated interest rate environment, with yield on H1 2025 interest earning assets at 7.29% compared with 6.56% in H1 2024.

Funding Costs

Interest expense jumped 87% year on year to N272.49bn, driven by a 22% rise in payments on customer deposits to N166.75bn and a 95% surge in payments on deposits from banks to N75.12bn. In contrast, payments on borrowings fell 20% to N30.63bn even as total borrowings grew 13% year to date, reflecting the repricing advantage of the Group's liability structure, where short term obligations adjust more quickly to the softer yield environment. As a result, cost of funds eased to 2.41% from 3.04% in H1 2024. Overall, interest bearing liabilities were up 4% year to date, supported mainly by growth in customer deposits and borrowings.

Credit Costs Reflect Regulatory Pressure

Credit costs spiked as impairment charges rose 190% to N148.15bn from N51.05bn in Q2 2024, following the CBN directive on unwinding forbearance and enforcing the Single Obligor Limit (SOL). Management reiterated during the last investor call that these assets remain active and revenue generating, having been re-tenored to match borrower cashflows, while unresolved exposures are expected to be fully provisioned by year end. Nevertheless, net interest income after impairments rose 65% to N391.49bn from N237.03bn in Q2 2024.

Non-Interest Income Trends


Fee and commission income provided some uplift, rising 34% to N90.85bn on the back of a 30% growth in electronic banking fees, 36% growth in account maintenance charges and a h.oladehinde@wstc.com.ng 53% increase in other fees, although fee and commission expenses jumped 72% to N16.26bn. Overall, the 45% decline in non interest income was almost entirely explained by the fair value losses, which were in turn linked to relative stability in the naira during the quarter. Operating income therefore grew 16% to N476.82bn from N412.71bn.



Elevated Operating Costs

Operating expenses rose by 31%, driven by a 47% rise in personnel costs and a 26% jump in other operating expenses, reaching N185.52bn from N147.82bn in Q2 2024. This pushed the cost-to-income ratio higher to 64% from 57% in Q2 2024, a level that closely aligns with historical averages outside the exceptional FX linked gains of Q2 2023 and Q2 2024 which had temporarily suppressed the ratio to 44% and 57%, respectively.

Consequent to the jump in impairment, disappearance of FX linked gains and higher cost, profit before tax fell 5% to N169.45bn, while profit after tax contracted 26% to N116.16bn, further pressured by a 150% spike in income tax which pushed the Q2 2025 effective tax rate to 31%, far above the seven-year Q2 average of 12%.

Recapitalisation Plans

The group announced plans to raise an additional N350bn in H2 2025, to be executed in phases through private placement, as part of its recapitalisation exercise.

Valuation and Outlook

Following the weaker bottom line, we now forecast FY 2025 profit after tax at N600.79bn, lower than our earlier projection of N719.43bn. The downgrade reflects higher impairment charges, now estimated at N417.38bn (vs N304.74bn previously), as the Group continues to make provision in line with regulatory directives. Interest income will remain the primary driver of earnings, while the non-recurring exceptional FX gains, alongside persistent cost pressures, will weigh on profitability.

Our fair value estimate has been revised upward to N32.49 per share, from N30.75 in our previous report. At the market price of Friday's close at N31.60, this implies a capital appreciation potential of just 3%. Factoring in dividend yield, total return rises modestly to around 7%, which we view as insufficient to sustain our **BUY** case as we now recommend a **HOLD**.
