# **NESTLE NIGERIA PLC**



....Sustained Revenue Growth and Lower FX Losses results in Strong Bottomline

Earnings Note

Nestle Nigeria Plc ("the Group") delivered a strong comeback in Q2 2025, posting results that underline both improved operating resilience and disciplined financial restructuring. Revenue grew by 28% year on year to N286.23 billion, compared to N223.49 billion in Q2 2024. Although this performance looks moderate against the unusually high 67% topline surge in Q2 2024, it is important to note that the 2024 growth was largely inflated by steep price increases implemented to offset soaring input costs during a period of high inflation. The Q2 2025 performance reflects a more sustainable growth path, built on stable consumer demand and robust product performance.

The Food segment was the standout performer, expanding by 84% year on year, while Beverages rose by 68%. This highlights Nestle's ability to preserve demand across its core categories, supported by strong brand loyalty and the essential nature of its product offerings.

On the cost side, the Group achieved greater efficiency. Cost of sales rose by 27% to N181.00 billion from N145.25 billion, which was slower than the pace of revenue growth. This allowed gross profit to expand and gross margin to improve to 37% from 35% in Q2 2024. The improvement was supported by easing inflationary pressures.

Operating expenses, however, put some pressure on margins. Total operating expenses climbed by 35% year on year to N48.69 billion from N36.19 billion in Q2 2024. The increase was largely driven by a 98% jump in administrative expenses, which reflected higher staff related costs and investments in corporate initiatives. Marketing and distribution expenses also rose by 24% as Nestle intensified efforts to strengthen product availability and market reach. Despite this rise in costs, operating profit advanced by 34% to N56.26 billion compared to N41.95 billion in Q2 2024, with operating margin expanding slightly to 20% from 19%.

The real turnaround in Q2 came from foreign exchange movements. Nestle recorded an FX gain of N3.30 billion, a sharp reversal from the N72.04 billion FX loss in Q2 2024. This improvement was supported by deliberate financial strategies, including the restructuring of short-term debt, the settlement of a \$20 million foreign currency loan and the relative naira stability.

Interest expense also provided some relief, declining by 16% to N22.96 billion from N27.30 billion in Q2 2024, following the debt restructuring. Finance income, however, fell by 14% to N645.85 million from N747.48 million in Q2 2024. Taken together, the lower finance cost and softer finance income brought net finance cost down to N22.31 billion from N26.55 billion in Q2 2024.

Together, these developments powered a dramatic bottom line recovery. Nestle swung from a loss after tax of N34.23 billion in Q2 2024 to a profit after tax of N20.39 billion in Q2 2025.

#### **OUTLOOK**

We project Nestle Nigeria will close FY 2025 with revenue of N1.29 trillion and profit after tax of N119.53 billion, consolidating its return to profitability. Importantly, the Group's balance sheet is expected to strengthen significantly, with total equity rebounding to a positive N27.24 billion from a loss position of N92.29 billion in FY 2024. This recovery underscores the impact of sustained earnings growth and disciplined capital management.

In line with this, we are factoring in a cautious dividend of N15.08 per share, translating to a modest payout ratio of 10%. While this represents a low yield of 1%, we believe the restrained payout might reflects management's priority to rebuild capital and restore balance sheet resilience after the erosion of equity in the prior year. We believe this conservative approach is prudent, as it positions Nestle for greater dividend-paying capacity in subsequent years once its financial base is fully normalised.

On valuation, we revised our fair value estimate upward to N2,520.31 (from N2,083.18 previously). At the current market price of N1,870.00, this implies a total return potential of 36% inclusive of dividends. Furthermore, our forecasted forward P/E multiple of 12.40x remains significantly below its historical average of 24.13x, highlighting that the market is yet to fully price in the earnings rebound. This undervaluation presents an attractive entry point for long-term investors seeking exposure to a company with renewed growth visibility and improving fundamentals. Accordingly, we maintain our **BUY** recommendation.
