... Earnings Strength Priced In; Limited Upside Ahead

Stanbic IBTC ("the Group") delivered a strong performance in the second quarter of 2025, with notable improvements across key financial indicators. One of the standout achievements was the significant growth in its net interest margin, which rose to 3.94% from the 2.80% recorded in the first half of 2024. This impressive expansion in net interest margin is primarily attributed to a reduction in the Group's cost of funds.

A key driver of this decline was the sharp drop in the cost of borrowed funds (inclusive of debt securities) from 5.17% to 2.82%, which also coincided with the deliberate scaledown of the balance sheet value which fell substantially to N492.47 billion from N627.64 billion. This decline in borrowing costs reflect the softening yields amid disinflationary trend and expectation of rate cut which later materialised in September 2025.

Specifically, the cost of funds declined to 1.71% from 2.14% in H1 2024.

In terms of top-line performance, Stanbic IBTC recorded a 39% year-on-year jump in gross earnings, which rose to N281.63 billion in Q2 2025, up from N202.17 billion in the corresponding period of the previous year. This growth in gross earnings was largely driven by a substantial 57% growth in interest income. The surge in interest income was facilitated by the relative elevated interest rate environment which provided a more favorable yield landscape for interest-earning assets.

In parallel, the Group demonstrated enhanced cost efficiency in managing its interest obligations, as evidenced by a decline in the interest expense margin to 13.56%, compared to 16.29% in Q2 2024. This suggests that while interest income rose significantly, the associated costs did not increase at the same pace, thereby supporting stronger net interest outcomes. In periods of yield moderation, the impact is typically more pronounced on the liability side of banks' balance sheets. Deposits and borrowings tend to reprice faster than loans and investment securities, allowing banks to benefit from lower funding costs before asset yields fully adjust.

While the Group faced challenges on the trading front, with trading revenue dropping by 72% to N6.11 billion from N22.09 billion in Q2 2024 on the back of a decline in fixed income and currencies, this was offset by resilience in other non-interest revenue streams. In particular, the Group recorded an 8% growth in total non-interest revenue, which printed at N77.32 billion from N71.85 billion.

The growth in non-interest revenue was underpinned by a 36% uplift in fees and commission income, driven largely by strong growth in brokerage and financial advisory fees and a significant jump in foreign currency services income, alongside the uptick in net insurance service result, which recorded an astonishing 493% increase. Overall, operating income grew to N230.90 billion – a 40% jump.

On the cost side, the Group experienced a 45% rise in operating expenses, which rose to N89.02 billion from N61.47 billion in Q2 2024. This growth was primarily due to a 33% rise in staff-related expenses, alongside a 51% increase in other operating expenses.

Nevertheless, cost-to-income ratio improved by 100 basis points, reflecting greater operational efficiency and a better balance between revenue generation and expenditure.

Profitability remained strong during the quarter as profit before tax rose by 51%, reaching N127.33 billion from N84.29 billion in Q2 2024. After accounting for a steep 165% increase in income tax expense, the Group still managed to post a 29% growth in profit after tax. Net profit stood at N91.37 billion in Q2 2025, up from N70.72 billion in Q2 2024.

Outlook

Following a comprehensive review of the Group's performance and macro assumptions, we estimate the fair value of the stock at N97.66 (previously: N88.29). Our projection is anchored on an interest income of N783.40 billion and a lower interest expense of N137.57 billion, reflecting softening yields and reduced funding costs. Consequently, we forecast a net interest margin of 8%, above the Group's 6%–7% guidance.

We also project a 65% year-on-year growth in profit after tax to N371.41 billion, translating to an EPS of N23.36 (FY 2024: N17.39) and a total dividend of N6.75 (including the N2.50 interim payment).

At the current market price of N118.00, the stock offers a total return of -12% after accounting for the 6% dividend yield. Notably, the share price has appreciated by 99% since our last report. Accordingly, we downgrade our recommendation to **SELL**.
