NOTICE IS HEREBY GIVEN that the Forty-Eight (48th) Annual General Meeting ("AGM") of the members of VERITAS KAPITAL ASSURANCE PLC ("the Company") will be held on Friday, the 31st of October 2025, at Shehu Musa Yar'Adua Centre, One Memorial Drive, Central Business District, Abuja-FCT, at 11:00 am to transact the following:

ORDINARY BUSINESS

- 1. To lay before the members, the Audited Financial Statements of the Company for the year ended December 31, 2024, together with the Reports of the Directors, Auditors, and Audit Committee thereon.
- 2. To ratify the appointment of the following Directors:
 - a. Dr. Adaobi Nwakuche Executive Director
 - b. Mr. Babatunde Irukera Non-Executive Director

That the share capital of the Company be and is hereby increased to such amount as may be determined by the Board of Directors ranking pari passu in all respects with the existing ordinary shares of the Company and that the new shares thus created be allotted pursuant to the Equity Issue and registered with the Securities & Exchange Commission, the Corporate Affairs commission and The Nigerian Exchange Limited and consequently that the Memorandum and Articles of Association of the Company be amended accordingly to reflect the Company's new share capital and any applicable amendment in line with the Companies and Allied Matters Act (CAMA 2020) there
 - c. That the Board of Directors be and is hereby authorised to approve, sign and/or execute all documents, appoint such professional parties and advisers, as may be necessary to give effect to the above resolutions, including, without limitation, complying with the directives of any regulatory authority.
 - d. That all acts carried out by the Board of Directors and/or Management of the Company in connection with the above be and are hereby approved and ratified.
 - e. That the Board of Directors be and are hereby authorised to perform other acts, take other steps or do all such other things as may be necessary for or incidental to, or as they deem appropriate to give effect to the spirit and intendments of the above resolutions.
- 8. To approve the remuneration of the Non-Executive Directors of the Company for the year ending December 31, 2025.
- 9. To appoint Planet Governance Advisory Limited as Board Evaluation Consultant.

1. PROXY

2. STAMPING OF PROXY FORM

The Company has made arrangements at its cost for the stamping of the duly completed and signed proxy forms submitted to the Company's Registrars within the stipulated time.

3. AUDIT COMMITTEE

In accordance with Section 404(3) of the Companies and Allied Matters Act 2020, the Audit Committee shall consist of five members comprising three Shareholders and two Non-Executive Directors. Section 404(6) of the Act also provides that any member may nominate a shareholder as a member of the Audit Committee by giving notice in writing of such nomination to the Company Secretary at least twenty-one days before the Annual General Meeting.
